DUST COLLECTOR (SB14) consisting of: A Torit Model HPT96 pulse-cleaned dust collector equipped with 96 3" by 6" oval 96" 16 ounce polyester felt bags totaling 954 square feet of filter area and a 20 hp blower generating 8100 cfm (for an air to cloth ratio of 8.5:1). This device serves the Small Batch Center (B009770).
