Flow Rate of 2400 cfm, outlet area of 0.70 sq ft, Pulse Jet Type, Air Consumption of 9 CFM@75 psi max, Particulate Grain Loading; Inlet of 30, and Outlet of 0.01. Equipped with 28 Cartridge Type Filters; 5.25 inch OD X 30 inches high each. Manufactures Efficiency of 99.98%. * This style unit dose not use magnehelic gauge. Dust Collector performance is measured by back pressure at load line. Facility Elevation is 1727 feet above sea level.

CONDITIONS:

- 1. The owner/operator (o/o) shall maintain this baghouse in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. [District Rule 204]
- 2. This baghouse shall be operated concurrently and whenever the Ash Storage and Transfer process operating under valid District permit T013072 is in operation.

- 3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for two (2) years a log of the following information, which shall be provided to District personnel upon request:
- a. Weekly reading of baghouse back pressure date and value);
- b. Monthly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if visible emissions are

- d. Date of bag replacements; and,
- e. Date and nature of any system repairs.

- 4. This baghouse shall not discharge into the atmosphere an exhaust stream that exhibits greater than ten percent opacity. [District Rule 401]
- 5. This Baghouse shall not discharge more than 0.3 pounds per hour of PM-10 at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description. This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District.

- 6. The o/o shall maintain on-site a minimum inventory of replacement cartridges to assure compliance with these conditions. [District Rule 1303(A)]
- 7. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
