#### **Description:**

FLARE, PIPELINE NATURAL GAS consisting of: Hero T30U6 or Questor Q-5000 enclosed combustion device rated at 5 million scfd per day to be used for degassing residual natural gas from pipeline prior to pipeline maintenance operations.

#### CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2. No air contaminant shall be released into the atmosphere which causes a public nuisance. [District Rule 402]
- 3. The owner/operator shall not discharge into the atmosphere from any single source of emission whatsoever any air contaminant for a period or periods aggregating more than three minutes in any one hour which is as dark or darker than Ringelmann 1. [District Rule 401]
- 4. The owner/operator shall immediately utilize air assisted combustion, if flare exhibits smoke greater than Ringelmann 1. [District Rule 401]

5. The owner/operator shall maintain a pilot flame present at all times the flare is operational. [District Rule 1303]

6. Flare shall be equipped with automatic re-ignition provisions.

[District Rule 1303]

7. Flare shall only be used to burn pipeline gas during pipeline degassing.

[District Rules 204 & 431]

8. Only propane and natural gas shall be used as a pilot fuel.

[District Rule 1303]

9. The owner/operator shall limit the amount of natural gas flared in this equipment to less than 4 million standard cubic feet dry (MMscfd) per day and less than 400 MMscfd in any calendar year. [District Rule 1303]

10. The gas line to the flare shall be equipped with an operational volumetric flow rate indicator. [District Rule 1303]

11. The unit must not be located and operated at an existing facility or operation such that it becomes part of an existing stationary source as defined by District Rule 1301(Y).

12. The equipment shall not be located within 1000 feet of any K-12 school. [CH&SC 42301.6]

13. This equipment shall not combust more than 8 MMscfd at any one project location. [District Rule 1303]

14. Owner/operator shall maintain a daily operations log including the following information.? This log shall be kept with the equipment for a minimum of two years, and shall be provided to District personnel upon request.?

- A) Daily and annual fuel consumption records, and?
- B) Date and location of each fuel degassing project, and ?
- C) Date and nature of all equipment repairs.

- 15. Owner/operator shall provide written notification by email to reporting@mdaqmd.ca.gov to the District 10 days prior to the operation of this equipment at a location within the District.? A copy of each notification (either electronic or hardcopy) shall be kept on-site. The notification must include the following information:
- A) Location of operation (address or decimal coordinates);
- B) The permit number of the equipment; and,
- C) Contact information (name, phone number, and email address) of the operator.

16. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
