The o/o must notify the Mojave Desert Air Quality Management District (District) within ten days if a significant change occurs to the project or operations covered by this DCP (by mail, facsimile or email to DCP@mdaqmd.ca.gov).? An appropriately modified dust control plan application must be submitted to the District within thirty days of the change.

- 6. The o/o shall recertify this DCP annually through response to the renewal invoice and Rule 302. [Rules 302(J)(6) and 403(D)(9)]
- 7. The o/o shall pay submittal, resubmittal/recertification, site inspection, and site stability inspection fees as specified in Rule 302, Rule 403 and as specified above, or this DCP shall be deemed disapproved by the APCO. [Rule 403(D)(11)]
- 8. The o/o shall not cause or allow the emissions of fugitive dust from any transport, handling, construction or storage activity so that the fugitive dust is visible in the atmosphere beyond the property line of the emissions source. [Rule 403(C)(1)]
