CREMATORIUM, ANIMAL consisting of:Industrial Equipment & Engineering Co., Model IE43-PPJ Power-Pak Junior; using LPG/Propane or Natural Gas for fuel. This equipment has a maximum heat input of 2.0 MMBtu/hour with a combustion air flow rate of 2500 scfm. The maximum loading capacity is 300 lbs with a maximum incineration capacity of 75 lbs/hour.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2. This equipment shall be operated by trained personnel; operating instructions shall be available at the incinerator at all times. [District Rule 204]
- 3. This crematory shall only be used for disposal of animal remains. [District Rules 1302 and 1320]

- 4.This unit shall operate at a minimum temperature of 1500 degrees Fahrenheit in the Primary Chamber and a minimum of 1550 degrees Fahrenheit in the Secondary Chamber prior to the introduction of animal remains and throughout the cremation process. [District Rule 1303]
- 5.The maximum weight of animal remains introduced into this incinerator shall not exceed 300 pounds per batch. [District Rules 1303 and 1320]
- 6.The owner/operator shall maintain an operations log for this unit current and on-site for a minimum of two (2) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the following information for each day the equipment is in operation:
- a. The length of time operated. This time shall be calculated as the time between the time the burner is initially lit before the first batch of animal remains is cremated until the time the burner is turned off after the last batch of animal remains is cremated;
- b. Weight of animal remains cremated, to include recording the weight of each batch plus daily, monthly and yearly totals;
- c. The starting temperature reading (when the remains are first introduced into the incinerator), hourly temperature readings after the starting reading, and ending temperature of each batch processed; and
- d. The quantity of fuel consumed in standard cubic feet (if using natural gas) or gallons (if using propane), including recording monthly and yearly totals.

7. Visible emissions from this equipment shall not exceed Ringelmann 1 (20%) opacity for a period or periods aggregating more than three minutes in any one hour, as required by District Rule 401, Visible Emissions. Furthermore, this facility shall not cause a public nuisance as described in District Rule 402.

[District Rules 401 and 402]

8. This crematory incinerator may be operated for a maximum of eight (8) hours per day, five (5) days per week, fifty-two (52) weeks per year.

[District Rules 1303 and 1520]

- 9. This crematory incinerator shall process no more than 600 pounds of animal remains in any 24 hour period. [District Rules 1303 and 1520]
- 10. This crematory incinerator may be operated concurrently with the incinerator operating under valid District Permit 1009631, colocated at this facility. The daily combined weight limit of animal remains for both incinerators (1005217 and 1009631) shall not exceed 1,800 pounds.

11.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
