Description:

PAINT GUN (BLDG 621) consisting of: a Brinks MACH I, HVLP whose serial number is 621-001. This unit is used for painting outside of building 621 and will only use water based coatings whose VOC content is 0.65 lb/gallon.

CONDITIONS:

- 1. All coatings, diluents, thinners and solvents shall comply with District Rules 1114, 1115, 1116 and 442 in their entirety. These rules pertain to Wood Products Coating Operations; Metal Parts & Products Coatings Operations; Automotive Refinishing Operations and Photochemically Reactive Solvents respectively.
- 2. A daily log shall be maintained which contains at least the following items:
- a. Equipment used to apply coating;
- b. Type of coating used and its VOC limit under each applicable rule;
- c. Quantity of coating used and its VOC content;
- d. Total VOC emissions; and
- e. Type of material being coated.

This log shall be kept current, on-site for a minimum of five (5) years and provided to District personnel on request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB 2588.)

3. All equipment used at this facility shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier.
