#### **CONDITIONS:**

- 1. All coatings, diluents, thinners and solvents shall comply with District Rules 1115, 1118 and 442 in their entirety. These rules pertain to Metal Parts & Products Coatings Operations; Aerospace Vehicle Parts and Products Coating Operations and Photochemically Reactive Solvents respectively.
- 2. A daily log shall be maintained which contains at least the following items:
- a. Equipment used to apply coating;
- b. Type of coating used and its VOC limit under each applicable rule;
- c. Quantity of coating used and its VOC content;
- d. Total VOC emissions; and
- e. Type of material being coated.

This log shall be kept current, on-site for a minimum of five (5) years and provided to District personnel on request.

- 3. All equipment used at this facility shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier.
- 4. The total mass of VOCs emitted from this operation without regard to where or how it is generated shall be included in the facility cap for VOC.
