TANK, WASTE OIL HOLDING consisting of:2,650 gallon cylindrical tank 8 ft high and 8 ft in diameter with a 24 inch top entry manway, a 16 in by 30 in hinged top manway and six 4 in flange connections (inlet, outlet, drain, overflow, vent and level switch)

CONDITIONS:

- 1. This tank shall only be used for storing waste oil which comes from existing oily water separator.
- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

- 2.All information provided with the application is incorporated as conditions to construct and operate this equipment.

- 3.All installed equipment shall be maintained in strict accord with condition 2 above.
- 3.Only crankcase and other waste oil shall be transferred and/or stored into/in this tank. [District Rule 1302(C)(2)(a)]
- 4.All of the components of this tank, including but not limited to tanks, flanges, seals, pipes, pumps, valves, meters, connectors, shall be maintained and operated so as to prevent fugitive vapor leaks, fugitive liquid leaks, and excess organic liquid drainage during transfer, storage and handling operations.

- 5. The owner/operator shall maintain an operations log for this equipment, current and on-site (or at a central location) for a minimum of two (2) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:
- a. Record of liquids stored in this tank, verified by MSDS and by retention of the waste manifests issued upon disposal of waste oil.
- b. A log containing any repairs and maintenance conducted on this equipment. [District Rule 463 (D)(1) and (D)(3)].

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
