TANK #5 (NEAR BLDG 630) consisting of:one 5,000 gallon Bryant Tank System w/containment - located about 700 feet from facility 630.

CONDITIONS:

- 1.Only internal combustion engine crankcase drainage oil, spent radiator fluid or contaminated fuel may be stored in this tank.
- 2.The owner/operator (o/o) shall notify the District, in writing, thirty days prior to making any change in the material stored in this tank. Compliance with District Rules shall be assured by obtaining a modified permit for the proposed material prior to change of product to be stored in this tank.
- 3.Used crankcase oil, contaminated fuel or spent radiator fluid shall not be stored in the same tank at the same time.
- 4.The o/o shall maintain an operators log for this tank which, as a minimum, contains: the throughput, source of stored material; date and volume (weight) of waste oil sent to outside disposers, and the hauler. The log shall be maintained on-site for at least 2 years and presented to District personnel upon request.
