3. The odorant tank and the delivery truck used to fill the odorant tank must be equipped with a Two Point Phase I type vapor recovery system; this vapor recovery system must be utilized whenever the odorant tank is being filled. [District Rule 1302]

4.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
