- 2. The owner/operator may not change the material stored in any tank without approval and authorization from the District. [District Rule 1302(c)(2)(a)]
- 3. During the filling of these storage tank(s), the hose(s) from the delivery truck(s) shall be fitted tightly and correctly to the fill pipe(s). In addition, all flanges, seals, compressors, pumps, valves and other appurtenant equipment shall be maintained to prevent leakage. [District Rule 204]
- 4. All of the components of Surfactant Tank 3, including but not limited to tanks, flanges, seals, pipes, pumps, valves, meters, connectors, shall be maintained and operated so as to prevent fugitive vapor leaks, fugitive liquid leaks, and excess organic liquid drainage during transfer, storage and handling operations. This condition shall be verified via a visual inspection conducted on a monthly basis. Surfactant Tanks 1 and 2, and the Caustic Tank, are exempt from the inspection requirement as they are exempt from District Rule 463.

[District Rule 463(C)(3)]

- 5. The owner/operator shall maintain an operations log for this equipment, current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:
- a. Record of liquids stored in Tank 3; and,
- b. A log containing the date and results of the inspections specified by condition 4, and any repairs and maintenance conducted on this equipment.

[District Rule 463 (D)(1) and (D)(3), basis compliance verification]

6. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request. [District Rule 107(b), H&S Code 39607 & 44341-44342, and 40 CFR 51, Subpart A]
