PEBBLE CaO SILO consisting of: Diversified Storage Systems 4100 cuft capacity (26,357 gallons) The Pebble CaO Silo holds calcium oxide (also known as "quicklime"). Lime is delivered to the silo for storage, then dispersed into haul trucks for transport to the ore pad.

- 2. Calcium oxide ("quicklime") may not be added to this silo unless the binvent is properly functioning. [District Rule 1302]
- 3. The owner/operator shall comply with all applicable rules and regulations of the District. Applicable rules include, but are not limited to the following: 401, 402, 403, and 430.
- 4. The throughput to this equipment shall not exceed 18,750 tons per year. [District Rule 1302]
- 5. The owner/operator shall conduct a minimum program of inspection and maintenance on this equipment. The owner/operator shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:
- a. Monthly truck loadout observation date and result (using USEPA Method 22, and USEPA Method 9 if a Method 22 detects opacity);
- b. Date and nature of any system repairs; and
- c. Monthly total of material added to the silo.

6. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
