Description:

ABRASIVE BLAST UNIT consisting of: Kelco model K124A with an ICM Utility Cyclone 5000 and UC 5000 After Filtration Section which is essentially a bag-collector

CONDITIONS:

1. This unit shall only use abrasives that have been certified by the California Air Resources Board (CARB).
2. Abrasive blasting operations within any permanent building shall not discharge into the atmosphere emissions which have an opacity of 10%.
3. Dry abrasive blasting using ARB-approved abrasive and no other control shall be used only on surfaces sufficiently free of excess deposits to prevent emissions >20% opacity for more than three minutes in any one hour.
4. Dry abrasive blasting operation shall be shrouded and/or exhausted through filters to prevent emissions >20% opacity for no longer than three minutes in any one hour.
5. The owner/operator (o/o) shall operate this equipment in strict accord with the manufacturer's specifications and/or sound engineering principles.

6. The o/o shall maintain a log which contains the mass of abrasive blast materials used, dates, and times of use. The log shall be maintained current, on-site for a minimum of two years and provided to District personnel on request.

7. The o/o shall be required to comply with all the Rules and Regulations of this District. Applicable rules are included in, but not necessarily limited to, Regulations IV and XIII.

8. The abrasive blasting system shall not be operated more than eight (8) hours in any one day, midnight to midnight.

NOTE: The opacity limit is 40% when using iron and/or steel shot and/or grit; and/or CARB certified abrasive materials per Title 17, Section 92520 of the California Code of Regulations.
