ABRASIVE BLASTER, ROTARY (BLDG 573 SMALL ARMS) consisting of:Goff table blaster, Model 72PTW/1016DC, with an abrasive reclaim system (screw auger and elevator) and integral dust collector (3 HP, 1000 CFM blower; 10 filter cartridges, each 8 inches diameter x 16 inches long, with a total filter area 540 sq. ft.) Facility Elevation is 1964 ft above MSL.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302(B)(1)(a)]
- 2. This abrasive blasting booth shall not be operated unless vented to the functioning air pollution control device listed in the above Description.

- 3. This abrasive blasting booth must be equipped with tight fitting seals around all openings, doors, windows, seams, etc. so as to prevent the escape of particulate matter into the ambient air while in use. [District Rule 1302(B)(1)(a)]
- 4. The owner/operator shall not discharge into the atmosphere a visible emission with a shade as dark or darker than Ringelmann 1, or

- 5. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below for each date of use:
- a. Number of hours used;
- b. Manufacturer's name and product name/code number of each abrasive material used; and
- c. Quantity of each abrasive material used, in pounds.

6. The District does not currently require periodic source testing of this abrasive blasting booth or its associated air pollution control device, although such testing may be required in the future.
