Description:

BLAST UNIT consisting of:a Schmidt Model 6.5CF single chamber sandblast machine, 6.5 cu ft capacity, powered by facility compressed air system with a maximum of 120 PSIG. With one Axxiom abrasive-blasting nozzle with a maximum inside diameter of 5/8 inches.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]

2.Except as provided in Condition 3, all abrasive blasting operations shall be conducted within a fully enclosed area. [Title 17 CCR, Section 92000 et seq.; District Rules 1302 and 1303]

- 3.An abrasive blasting operation conducted under one or more of the following conditions is not required to be fully enclosed:
- (1) Steel or iron shot/grit is used exclusively;
- (2) The item to be blasted exceeds 8 feet in any dimension; or
- (3) The surface being blasted is situated at its permanent location or no further away from its permanent location than is necessary to allow the surface to be blasted.

4. This unit shall only use abrasives that have been certified by the California Air Resources Board (CARB) when used outside of a fully enclosed area.

[Title 17 CCR 92500(c), District Rule 1302]

- 5.Emissions from abrasive blasting operations shall not exceed the following visible emission limits for a period or periods aggregating more than three minutes in any one hour;
- a. Fully enclosed blasting- 20 percent opacity (Ringelmann 1).
- b. Open outdoor blasting- 40 percent opacity (Ringelmann 2).

[Title 17 CCR 92200, District Rule 401]

6. The owner/operator shall not discharge from this abrasive blasting equipment such quantities of air contaminants or other material which cause injury, detriment, nuisance or annoyance to any considerable number of persons or to the public, or which endanger the comfort, repose, health or safety of any such persons or the public, or which cause, or have a natural tendency to cause, injury or damage to business or property.

- 7.The amount of abrasive blast media blasted through this equipment shall not exceed the following amounts, depending on the type of blasting being conducted:
- a. No more than 870 pounds per day when conducting unconfined blasting;
- b. No more than 3480 pounds per day nor more than 1.27 million pounds per year when conducting confined (controlled) blasting. [District Rules 1302 and 1303]
- 8. This abrasive blasting booth must be equipped with tight fitting seals around all openings, doors, windows, seams, etc. so as to prevent the escape of particulate matter into the ambient air while in use.

 [District Rule 204]
- 9. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below for each date of use:
- a. Number of hours used;
- b. Manufacturer's name and product name/code number of each abrasive material used;
- c. Quantity of each abrasive material used, in pounds; and
- d. Type of blasting being conducted (confined or unconfined).

10. The owner/operator shall not cause or allow the emissions of fugitive dust from any abrasive blasting operations, transport, handling, construction or storage activity so that the presence of such dust remains visible in the atmosphere beyond the property line of the emission source.

11.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
