5.The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District, State and Federal personnel upon request:
a. Monthly transfer and fugitive emission point observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary); and,
b. Date and nature of all repairs and maintenance on this equipment.

5.This equipment shall not discharge into the atmosphere an exhaust stream that exhibits greater than ten percent opacity from any transfer point or other fugitive emission point [Rule 204, 40 CFR 60.672(b)(2)]

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
