- 2. The owner/operator shall comply with all applicable Rules and Regulations of the District. Applicable Rules include but are not necessarily limited to Rules 401, 402, 403 and 430.
- 3.Roadways, work areas, stockpiles, and materials being processed shall contain sufficient natural and/or added to ensure compliance with all applicable District Rules. Equipment to properly wet the material being processed shall be maintained in operable condition onsite.
- 4. The owner/operator (o/o) shall maintain a log which contains at a minimum:
- a. tons/day of aggregate processed;
- b. total number of hours operated;
- c. all inspections daily;
- d. repairs, and maintenance on equipment as performed.

Logs shall be maintained at either the facility or corporate office for at two (2) years and available to District, State, or Federal personnel upon request.

- 5. This facility shall emit less than the following in any twelve (12) month period:
- a. 12 tons of PM10;
- b. 8 tons per year of any single HAP or 20 tons per year of any combination of HAPs.

Compliance with this limit shall be verified with monthly facility emission summaries and rolling 12 month average. Monthly emissions summaries shall be calculated using a District-approved method, with at least the last two years of monthly emissions summaries maintained for a minimum of two years and provided to District, State or Federal personnel upon request.

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
