## **Description:**

FIRE TRAINING AREA (BLDG 1912) consisting of:A simulated housing burn room for indoor burns, an outside burn area for outside burns, and burn boxes for smoke training.

#### CONDITIONS:

- 1. The District shall be notified by telephone at (760) 245-1661 at least 24 hours prior to commencing each live fire and/or smoke training exercise.
- 2.Live fire and/or smoke training exercise shall only be conducted on disignated burn days as designated by the District and/or CARB.
- 3.Only wood and/or paper can be burned in the Burn Room. The maximum amount of wood and/or paper that can be burned at any one time is 250 pounds.
- 4.Only vehicles can be burned in the Burn Area. The maximum number of vehicles that can be burned at any one time is one (1).
- 5. Written records shall be kept for each day and shall be maintained on-site for at least two (2) years and shall be made available to the District upon request. The records shall include the following:
- A. Time and duration of each training exercise.
- B. Type and quantity of all materials burned,
