## CONDITIONS:

- 1.This equipment shall operate in strict accord with all information submitted with the application unless specifically exempted hereunder.
- 2.The crushing/screening plant shall not be operated unless the spray system is operating properly.
- 3.Materials processed by this plant equipment in addition to haulways, roads and throughways of the plant shall contain sufficient natural and/or added moisture to ensure compliance with District rules 401 and 403. Sufficient water, chemical agents and equipment in operable condition shall be maintained on-site and used as necessary to ensure compliance with the above mentioned rules.
- 4.Operation of the equipment described in this permit shall be restricted to a maximum throughput to the Jaw Crusher of 500 t/h. The o/o shall install a device which measures this throughput if one has not been previously provided. An alternate means of estimating the throughput to the satisfaction of the District will be considered.
- 5.The operation of this crushing plant is limited to 2080 h/year. The owner/operator, o/o, shall log the throughput to the jaw crusher on a daily basis.
- 6.The o/o shall maintain logs current, on-site for a minimum of 2 years and provide them to District personnel on request.
