**Description:**

CRUSHING & SCREENING consisting of: at AREA "R" COMPLEX, a Jaw crusher by Eagle, model 54D470, serial number 10531. This circuit contains conveyors, water sprays, shakers and screens. Included is the necessary electrical, valving, controls for the operation. This circuit is powered by an ICE, which is rated at 141 bhp and driving a generator, under valid District permit B004494.

**CONDITIONS:**

1. Operation of this equipment shall be in strict compliance with all the information submitted with the application for which this permit has been issued, unless specifically exempted hereunder.
2. This equipment shall not be operated more than 900 hours per calendar year. The owner/operator, o/o, shall limit the throughput of the crusher circuit to 75 ton/h and shall install a device which measures this throughput if one has not been installed. An alternate method of estimating the throughput to the crusher will be considered by the District.
3. The o/o shall maintain a log of the hours of operation and throughput to the crusher hopper in ton/h. This log shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request.
4. Materials processed by equipment delineated above shall contain sufficient and/or added moisture to ensure compliance with District rules 401 and 403. Sufficient water and equipment in operable condition shall be maintained on-site and used as necessary to ensure compliance with these rules. Included shall be open pit material loading by front end loaders, transport by truck from stock piles or open pit mine to the crusher and truck dumping into the crusher and/or storage areas. Fugitive dust control for all operations shall be routine, on a day to day basis. Unpaved road emissions generated by vehicular traffic shall be ameliorated by the use of water trucks, water canon or the application of chemical stabilizers.
