#### **Description:**

DRUM MIX ASPHALT PLANT consisting of: Cedar Rapids Model 100/32; drum mixer dimensions, 32'l x 8.3' dia; equipped w/ low NOx burner rated @ 116 million Btu/h using propane fuel. Ancillary equipment includes: 125 hp motor drive for the mixer, conveyor (slat), asphalt oil pump; a 4 hopper receiving system; feeders; classifying screen (4' x 8'); collecting belt conveyor; air compressor; diesel fuel tank; and 1971 Caterpillar 50 kW generator.

#### **CONDITIONS:**

1. The owner/operator (o/o) shall install, operate and maintain this equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce minimum emissions of air pollutants.
2. The owner/operator (o/o) shall restrict the operation of this equipment to 11 hours/day.
3. The o/o shall log the total hours of operation, total tons of material processed, and the maximum hourly production rate. This log shall be maintained current, on-site for a minimum of two (2) years and provided to District personnel on request.
4. Use of diesel fuel plant wide shall be limited to that whose sulfur concentration is equal to or less than 0.05%.
5. The o/o shall notify the District in writing within 10 working days of each of the following:
  - a. Placement of any equipment at this site
  - b. Start-up of equipment for shake down purposes, and
