Air slide 351AS101, kiln feed feeder 351AL101, and pneumatic line 351PI101 shall not be operated unless vented to baghouse C007408 (351BF101). Bucket elevator 351BE101 and kiln feed bin shall not be operated unless vented to baghouse C007407 (351BF102). Weigh feeder 351WF351 and chain conveyors 351CV550 and 351CV551 shall not be operated unless vented to baghouse C007494 (351BF510). [District Rule 204; 1303(A)]

3.All equipment shall be operated in compliance with applicable requirements 40 CFR 63 Subpart LLL - National Emission Standard for Hazardous Air Pollutants from the Portland Cement Manufacturing Industry.
