#### **CONDITIONS:**

1. Operation of this equipment shall be conducted in accordance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
3. The owner/operator (o/o) shall use only diesel fuel whose sulfur concentration is less than or equal to 0.05% on a weight per weight basis in this unit.
4. The o/o shall maintain a log for this unit, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:
  - a. Fuel consumed during each calendar year, in gallons; and,
  - b. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log).

5.This equipment shall not exceed the following emission rates:

- a. 7.0 gm/bhp-hr of NO<sub>x</sub>
- b. 1.0 gm/bhp-hr of VOC
- c. 0.38 gm/bhp-hr of PM<sub>10</sub>

6.The o/o shall perform an initial compliance test in accordance with the MDAQMD Compliance Test Procedural Manual and a District-approved test plan (source tests during subsequent years may be required at the District's discretion). The o/o shall submit a written test plan for District review and approval thirty (30) days prior to the test. Written notice of the test shall be provided to the District ten (10) days prior to the tests so that an observer may be present. The test report shall be submitted to the District not later than four (4) weeks prior to the expiration date of this permit. The following compliance tests are required:

- a. NO<sub>x</sub> as NO<sub>2</sub> in lb/hr
- b. VOC as CH<sub>4</sub> in lb/hr
- c. PM<sub>10</sub> in lb/hr
