**CONDITIONS:**

1. Materials processed by the equipment described above shall contain sufficient natural and/or added moisture to preclude violations of District rules 401, 402 and 403. Sufficient water and the equipment to apply it in the process and haul roads as necessary shall be maintained on-site for the duration of this project and in proper working order.
2. The Cone Crusher shall not be operated unless vented to the properly functioning baghouse under valid District permit number C007755.
3. The owner/operator, o/o, shall process no more than 5400 ton per 24 hour period, which begins at 12:00 midnight, nor more than 250,000 ton per any 12 consecutive month period to the Vibrating Grizzly Feeder. The o/o shall demonstrate to the satisfaction of the District, prior to start-up of the equipment, that the method for determining the measure of throughput is accurate and reproducible. Note: This is consistent in the limitations of the emissions pursuant to District rules 1303(A)(1 and 3) and 1303(B)(1), which pertain to BACT and offsets respectively.
4. The o/o shall log the throughputs to the Vibrating Grizzly. The log and the method of determination of throughput to the Vibrating Grizzly shall be maintained current, on-site for the duration of the project and provided to District personnel on request.
5. All the information provided with the application under which this ATC is issued, is an integral part of this ATC and acts as specific limitations on the operation of this equipment.
