#### **Description:**

PORTABLE DIESEL IC ENGINE (26-386), WELDER consisting of:

One Lincoln 87U fired internal combustion engine Model No. SAE-400 and Serial No. F227A605803S54333, producing 68 bhp with 6 cylinders at 1800 rpm while consuming a maximum of 1.0 gal/hr. This equipment powers a Lincoln Welder Model No. SAE-400 E245 and Serial No. A-928874, rated at 400 AMP DC.

#### **CONDITIONS:**

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.
2. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time.
3. This diesel ICE and its associated equipment cannot be operated at the same engine-print (spot) for more than 365 consecutive days. (This system must be moved within this facility or moved to another facility annually.)
4. This unit shall only be fired on unleaded gasoline.
5. The owner/operator (o/o) shall maintain an operations log for this unit current and on-site, either at the engine location or at a on-site location, for a minimum of five (5) years, and for another year where it can be made available to the District staff within 5 working days from the District's request, and this log shall be provided to District, State and Federal personnel upon request.
