- 2. This equipment shall not be operated unless the associated Up/Down Hopper and truck loading interface is vented through a properly operating baghouse with a valid District permit C009504.

 [District Rule 204]
- 3.The o/o shall ensure that the materials used in the equipment contain sufficient natural and/or added moisture to preclude violations of District rules 401, 402, 403 and Regulation XIII. These rules pertain to opacity, dust blowing off of the property, nuisance and new source review. The o/o shall maintain sufficient water and equipment for its application in operable condition and on-site, and use it as necessary on material piles, haul roads, and in the plant to prevent violations of the above rules.

- 4.Cement and Fly Ash Truck unloading shall only occur through a properly operating pneumatic truck unloading system, and only into designated storage silos, venting to properly operated and maintained Filter Vents.

- 5.Maximum concrete throughput shall not exceed 1.40 MMTPY.
 [District Regulation XIII]
- 6.A daily production and operations log shall be maintained at either the facility or corporate office for at two (2) years and available to District, State, or Federal personnel upon request. This log shall contain, at a minimum:
- a. Daily and annual tonnage of finished product;
- b. Weekly visible emission determinations at transfer points, date and result (using USEPA Method 22, and USEPA Method 9 if necessary),
- c. Maintenance and repairs on plant and supporting equipment, and
- d. Date and nature of any system repairs.

7.All open material transfer points, such as conveyor drops, hopper and bin loading, shall be equipped with water sprays to minimize emissions of particulate matter or material shall contain sufficient moisture to preclude any visible emissions per method 22 observations.

8.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
