BOILER consisting of: Natural gas fired commercial pool heater with a heat input of 2.07 MM btu/hr, and equipment rating of 1.8 MM btu/hr. Raypak model P-2072C, serial number V282201409.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or in a manner consistent with safety and good air pollution control practices for minimizing emissions. Furthermore, operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued.

2. This heater shall only be fueled with utility grade natural gas as fuel and shall be equipped with a meter measuring fuel consumption in standard cubic feet.

3. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
 - a. Total fuel consumed on an annual basis.
