CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]
- 2.Materials processed by equipment delineated above shall contain sufficient and/or added moisture to ensure compliance with District rules 401, 402, and 403. Sufficient water and equipment in operable condition shall be maintained on-site and used as necessary to ensure compliance with these rules.
- 3.Ball milling operations shall be performed in an enclosure and shall not discharge PM10 in excess of 1 lb/100 tons processed. [District Rule 1303 BACT]
- 4.Material handling processes (i.e. drops and conveyors) shall not discharge PM10 in excess of 0.01 grains/dscf. [District Rule 1303 BACT]
- 5.Material shall maintain a moisture content such that there shall be no visible emissions. [District Rule 1303 BACT]
- 6.Actual emissions from this facility shall be less than the following:
- a. 42 tons per year of NOx [Rule 1303(B)]
- b. 46 tons per year of PM10 [Rule 1303(B)]
- c. 25 tons per year of VOC
- d. 25 tons per year of SOx
- e. 100 tons per year of CO, calculated on a rolling twelve-month basis
- f. 10 tons per year for any single HAP and 25 tons per year for any combination of HAPs calculated on a rolling twelve-month basis. HAPs are defined in 40 CFR 61.01 and are the chemical compounds listed in section 112(b) of the Clean Air Act (Act).

Compliance with the annual emission limits shall be demonstrated via 12 month rolling sum for CO and HAP via annual emission inventory reports for all criteria pollutants and HAP.

[District Rule 1303 - Offsets]

7.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
