One Perkins, Diesel fired internal combustion engine Model No. C4.4 and Serial No. 44808101, After Cooled, Diesel Oxidation Catalyst, Compression-Ignited, Continuous Trap Oxidizer, Direct Injected, Electronic Control Module, Exhaust Gas Recirculation, Exhaust Gas Recirculation, Turbo Charged, producing 174 bhp with 4 cylinders at 2200 rpm while consuming a maximum of 9.0 gal/hr. This equipment powers a Terex Screen Model No. Phoenix Trommel 2100 and Serial No. TRX00176LDGF60677, rated at 7.4 cu. yds.

1.This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]

2.This diesel ICE and its associated equipment cannot be operated at the same engine-print (spot) for more than 365 consecutive days. (This system must be moved for a valid business purpose within this facility or moved to another facility annually.) [Title 17 CCR 93116.2(bb)]

3.This unit shall only be fired on ultra-low sulfur diesel fuel whose sulfur concentration is less than or equal to 0.0015% (15 ppm) per CARB Diesel or equivalent requirements; or alternative diesel fuel or CARB diesel fuel utilizing fuel additives that has been verified through the Verification Procedure for In-Use Strategies to Control Emissions from Diesel Engines. [Title 17 CCR 93116.3(a)]

4.The o/o shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:

- a. Calendar year operation in terms of fuel consumption (in gallons) or total hours;
- b. Descriptions of all breakdowns and repairs made to the engine or any emission control device; and,
- c. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log). [Title 17 CCR 93116.4(c)]

5.The fleet* under control of this o/o is subject to and shall comply with the weighted Diesel Particulate Matter (DPM) emission fleet averages** expressed as grams per brake horsepower-hour (g/bhp-hr) of Title 17 CCR Section 93116.3(c) & (d) by the following dates:
