Conveyor belt 561BC101 shall not be operated unless vented to baghouses C013001 (551BF101), C013004 (551BF104), C013002 (551BF102), C013003 (551BF103), and C013005 (571BF101). Belt conveyors 472BC103 and 561BC101 shall not be operated unless vented to baghouse C013003 (551BF103).
