CONDITIONS:

1. This certified Tier 4 Final stationary compression-ignited internal combustion engine and its associated emission control systems shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [40 CFR 60.4211(a); District Rule 1160]

2. This engine shall not be operated unless all of the following engine systems are properly functioning:

- a. Electronic Direct Injection
- b. Turbocarger
- c. Charge Air Cooler
- d. Engine Control Module
- e. Diesel Oxidation Catalyst
- f. Selective Catalytic Reduction-Urea
- g. Exhaust Gas Recirculation
- h. Ammonia Oxidation Catalyst

3. This equipment shall only be fired on diesel fuel that meets the following requirements, or an alternative fuel approved by the ATCM for Stationary CI Engines:

a. Ultra-low sulfur concentration of 0.0015% (15 ppm) or less, on a weight per weight basis; and,

b. A cetane index or aromatic content, as follows:

1. A minimum cetane index of 40: or.

2. A maximum aromatic content of 35 volume percent.

[17 CCR 93115.5(a), 40 CFR 80.510, and 40 CFR 60.4207(b)]

Note: Use of CARB certified ULSD fuel satisfies the above requirements.

4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [17 CCR 93115.10(d)(1) and 40 CFR 60.4209(a)]

5.Owner/operator shall conduct inspection, whichever is more frequent of, at least once every calendar guarter; or, after every 2,000 hours of engine operation. An inspection includes any testing, maintenance, and/or other procedures that ensure the Internal Combustion Engine is operated in strict accordance with the manufacturer's specifications and in continual compliance with the provisions of this rule.

6. The owner/operator shall maintain an operations log for this unit, current and on-site (or at a central location), for a minimum of five (5) vears, and this log shall be provided to District. State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:

a. Quarterly fuel use and quarterly hours of operation, on a calendar quarter basis;

b. The date and a summary of each engine inspection including any testing and maintenance performed.

c. Fuel sulfur concentration (may use the fuel supplier's certification of sulfur content if it is maintained as part of this log).

7. This engine is subject to the requirements of Title 17 CCR 93115, the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition Engines and 40 CFR 60, Subpart IIII - Standards of Performance for Stationary Compression Ignition Internal Combustion Engines (NSPS). In the event of a conflict between these conditions and the ATCM or NSPS, the more stringent requirements shall govern. [District Rule 1302]

8.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
