**Description:**

DIESEL PARTICULATE FILTER REGENERATION EQUIPMENT consisting of: OTC Model 5280 diesel particulate Soot Dislodging Filtration Device and OTC Model 5281 Regeneration Electric Oven. Vacuum equipped with HEPA filters to clean the Regeneration Electric Oven after each DPF cleaning cycle.

**CONDITIONS:**

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. This permit is contingent upon compliance with District Rule 402 - Nuisance. Upon receipt of violation of Rule 402, the District may require the owner/operator to submit, within 60 days of notification, a permit application for the installment of additional emission control and/or curtailment of operations until either the operation can be modified or the meteorological conditions change such that the operation of this equipment no longer cause nuisance.

3. A person shall not discharge into the atmosphere from any single source of emission whatsoever any air contaminant for a period or periods aggregating more than three minutes in any one hour which is:

4. Owner operator shall clean theregeneration electric oven using a vacuum equipped with HEPA filters after each DPF cleaning cycle.

5. The owner/operators shall keep replacement HEPA and cartridge filters on site for the soot dislodging filtration device.

[District Rule 1302(C)(2)(a)]

6. The owner operator shall inspect the HEPA filter at least once a month to ensure that it is sufficiently free of dirt and debris such that the HEPA filter operates properly.

7. The owner operator shall change the cartridge filters when the display indicates "internal filters bad". The filters shall be changed in the manner prescribed by the manufacturer and shall not be removed from the machine unless properly enclosed in plastic to contain soot.

8. An operations log shall be maintained with this equipment for at least two (2) years and made available to Federal, State, and/or District personnel upon request. This log shall contain, at a minimum:

a) The date and time of each DPF cleaned, and

b) The total quantity of DPF's cleaned in a consecutive twelve-month period (running cumulative total).

c) The dates of HEPA and/or cartridge filter replacements.

9. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
