2.All material conveyors and transfer points shall be skirted and covered to ensure all dust is collected by associated dust collectors. Belt conveyor 231BC300 shall not be operated unless vented to baghouse C013675 (231BF301). Belt conveyor 231BC301 shall not be operated unless vented to baghouse C013676 (231BF302). Conveyors 231BI300 and 461WF300 shall not be operated unless vented to baghouse C013677 (461BF301).  
[District Rules 204, 1303(A)]

3.Coke fuel shall only be stored in the material storage building or within a similarly constructed enclosure having half-walls and a roof.  
[District Rule 1303]

4.Visible emissions from the coal/coke material storage building must not exceed 10 percent opacity for 6 minutes in any one hour. Owner/operator shall carry out monthly visible emission (VE) determinations in accordance with 40 CFR Part 63, Subpart LLL. If no visible emissions are observed for six consecutive months, the frequency can change to semi-annually. If no emissions are observed semi-annually, the frequency can be changed to annually. If any visible emissions are observed, frequency reverts to monthly until no visible emissions are observed for six consecutive months. Owner/operator shall maintain a log of each monthly VE determination for a period of 5 years.

5.All equipment shall be operated in compliance with applicable requirements of 40 CFR 63 Subpart LLL - National Emission Standard for Hazardous Air Pollutants from the Portland Cement Manufacturing Industry.
