Description:

VOLUMETRIC CONCRETE BATCH PLANT #1 consisting of: a Cementech SCD 4.5-50 volumetric concrete batch plant, rated at 15 cubic yards per hour, and equipped with onboard storage for raw aggregates, water, and cement, an auger mixer, and a chute.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. The owner/operator shall ensure that the materials used in the equipment contain sufficient natural and/or added moisture to preclude violations of District rules 401, 402 and 403. These rules pertain to opacity, dust blowing off of the property and nuisance. The o/o shall maintain sufficient water and equipment for its application in operable condition and on-site, and use it as necessary on material piles, haul roads, and in the plant to prevent violations of the above rules.

3. This equipment and associated operations shall not discharge an exhaust stream that exhibits opacity greater than twenty percent (Ringlemann 1).

[District Rules 204 and 401]

4. The owner/operator shall conduct, at a minimum, a monthly visible emissions determinations using USEPA Method 22 for a minimum of five (5) minutes. If VE occurs the operator is required to implement corrective action within 24 hours to eliminate the VE and must record the corrective action, including the date and time the corrective action was taken.

5. A daily production and operations log (in electronic or hardcopy format) shall be maintained current and on-site for two (2) years, and shall be provided to District personnel upon request. This log shall contain, at a minimum:

- a. Daily cubic yards batched (summarized monthly).
- b. Monthly visible emissions determinations result and corrective action (if any).
- c. Date and nature of any system repairs.

6. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
