#### Description:

DIESEL IC ENGINE, PORTABLE GENERATOR consisting of: A Certified Tier 4 Final John Deere diesel engine, USEPA family MJDXL02.9303, manufactured in 2019. Exhaust flow is approximately 400 acfm, at 1200 degrees Fahrenheit through a 3.5 feet high by 0.33 feet diameter exhaust stack.

One Generac, Diesel fired internal combustion engine Model No. 3029HFG03 and Serial No. CD3029U147228, Turbo Charged, After Cooled, producing 59 bhp with 3 cylinders at 1800 rpm while consuming a maximum of 3.9 gal/hr. This equipment powers a Generac Generator Model No. MMG55DF4 and Serial No. 3009699272, rated at 44 kW.

1. This certified Tier 4F diesel fired internal combustion engine shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles, which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

[District Rule 204 and 1302]

2. This unit shall only be fired on ultra-low sulfur diesel fuel whose sulfur concentration is less than or equal to 0.0015% (15 ppm) per CARB Diesel or equivalent requirements; or alternative diesel fuel or CARB diesel fuel utilizing fuel additives that has been verified through the Verification Procedure for In-Use Strategies to Control Emissions from Diesel Engines.

3. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time.

[Title 17 CCR 93116.4(c)(2)(A)]

4. The owner/operator shall maintain an operations log for this unit, current and on-site (or at a central location), for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:

a. Date, location, and duration of each use (in hours);

b. Monthly and consecutive 12 month period hour meter readings, including the dates of all monthly readings;

c. Description of each maintenance action or repair on any equipment; and

d. Fuel sulfur concentration as required by condition #2 (you may use the supplier's certification of sulfur content if it is maintained as part of this log).

5. This unit shall not operate within a 1,000 feet of the outer boundary of any K-12 school. Such operation will require the submittal of an application for a revised permit to operate so that the applicable requirements of the California Health and Safety Code Section 42301.6 will be met.

[H&S Code 42301.6; District Rule 1302(C)(2)(a)]

6. This engine and its associated equipment cannot be operated at the same location for more than 365 consecutive days. This equipment must be moved for a valid business purpose annually.

[District Rules 1302, 1303, and 1320 and Title 17 CCR 93116.2(a)(29)]

7. The facility-wide emissions must be less than the following limitations in each consecutive twelve-month period:

a. 80 tons per year of Carbon Monoxide (CO) per calendar year;

b. 20 tons per year of Oxides of Nitrogen (NO<sub>x</sub>) per calendar year;

c. 20 tons per year of Volatile Organic Compounds (VOC) per each consecutive twelve-month period;

d. 80 tons per year of Particulate Matter of 10 microns or less (PM<sub>10</sub>) per calendar year;

e. 20 tons per year of Oxides of Sulfur (SO<sub>x</sub>) per calendar year;

f. 8 tons per year of any single Hazardous Air Pollutant (HAP) per calendar year; and,

g. 20 tons per year of any combination of HAP per calendar year.

Compliance with these emission limitations must be verified by pollutant-specific emission summaries for each calendar year except for PM-10 which must be verified for each consecutive twelve-month period. These emission summaries must be retained on-site for a minimum period of five (5) years; and, must be made available for review upon request by District, State or Federal personnel.

In addition, this facility is designated as a Major Source of PM<sub>10</sub> under Regulation XIII - New Source Review, as it has a Potential to Emit in an amount equal to or greater than 15 tons per year of PM<sub>10</sub>; therefore, any new Permit Unit or any Modified Permit Unit at this facility must be fully offset pursuant to District Rule 1303(B).

8. This engine is subject to the requirements of Title 17 CCR 93116, the Airborne Toxic Control Measure (ATCM) for Diesel Particulate Matter from Portable Engines Rated at 50 Horsepower and Greater. In the event of a conflict between these conditions and the ATCM, the more stringent requirements shall govern.

9. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
