#### **Description:**

BAGHOUSE-SECONDARY DUST COLLECTION consisting of: by Fabric Filters Northwest, their model 765-10, pulse jet type with an air flow of 50,000 ACFM. Bags are of 18 oz duo-density polyester felt, approximately 10,000 square ft; Exhaust fan, 50,000 ACFM is rated at 150 hp; Screw conveyor, 9 in diameter, motor driven at 5 hp; Plattco double dump flap gates, air operated; Blower system, 5 ton/h at 15 hp; Storage Silo 11 ft diameter by 18 ft high is 225 barrel capacity; Transfer Screw Conveyor, 10 in; total hp = 177.5

#### **CONDITIONS:**

1. The owner/operator (o/o) shall operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier, and sound engineering principles which produce minimum emissions of air contaminants.
2. The o/o shall institute a program of maintenance which embraces at least monthly visible emission determinations, monthly visual inspections of all associated equipment (inclusive of the bags and their suspension systems) and regular (to be determined with experience with this unit) measurements of the pressure differential across the bags.
3. The o/o shall log all the items in 2 above in addition to the bag replacements, repairs and non-scheduled maintenance. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.

4. The o/o shall maintain an inventory of replacement bags on-site at all times which will ensure compliance with applicable Rules of District Regulation IV.
5. The o/o shall install and maintain a device which measures the pressure differential across the bags if one has not been provided with this unit.
6. This baghouse shall operate concurrently with the Asphalt Batch Plant under valid District permit number B002468.
