- 5. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request:
- a. Monthly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- b. Monthly bag and bag suspension system inspection date and results;
- c. Monthly reading of baghouse pressure drop, date and value;
- d. Date of bag replacements; and,
- e. Date and nature of any system repairs.
