BLUE SMOKE CONTROL EQUIPMENT # 2 consisting of: Visible emission control system to be used when applying asphalt-rubber during the spraying operation. This system includes the following: A. Hood, Front Collection - 8'W x 1'L x 18"H vented to two Farr Riga-Flo 200 filter, each 24" x 24" x 12". B. Hood, Rear Collection - 8'W x 6'L x 4'H vented to twelve Farr Riga-Flo 200 filters, each 24" x 24" x 12" with 24" x 24" x 4" pre-filters. C. Fans, Vane-Axial - New York Blower Model 246, each 15,000 CFM and 3170 RPM max. D. Extendible Sidewings for Rear Collection Hood and various duct work. E. Engine, IC - Deutz Model BF6L 913 and 135 hp used for driving fans and hydraulics system.

#### **CONDITIONS:**

1. Operation of this equipment shall be conducted in compliance with data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
2. The visible emissions from this blue smoke control equipment shall not exceed the limits allowed in District Rule 401.
3. The owner/operator (o/o) shall have a maintenance plan for this blue smoke control equipment. This plan, at a minimum, shall require a log that will include inspection/repairs frequency.
4. The maintenance log for this equipment shall be maintained with this equipment for two years and be made available to the District upon request.
