Description:

BAGHOUSE CEMSTAR (DC-7), KILNS 6-7 consisting of: Baghouse: DCE Volks, model DLM 15/15 K5, serial number 93-1643. This baghouse has 161 total square feet of surface filter area with an 8:1 air to cloth ratio. The fan is driven by a 4 hp motor producing an air flow of 1288 CFM @ 6 in static pressure. This unit picks up particulate matter from the No. 7 CemStar feeder discharge.

CONDITIONS:

1. The owner/operator, (o/o), shall install, operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier, and sound engineering principles which produce minimum emissions of air contaminants.
2. The o/o shall have a maintenance plan for this baghouse. This plan, at a minimum, shall require a log that will include visual emission readings on a regular basis, recording of differential pressures across the baghouse and inspection/repairs frequency.
3. The o/o shall log all the items in 2 above in addition to the bag replacements, repairs and non-scheduled maintenance. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
4. The o/o shall maintain an inventory of replacement bags on-site at all times which will ensure compliance with applicable Rules of District Regulation IV.
5. This baghouse shall operate concurrently with CemStar Feed System-Kilns 6 & 7 and the associated 5 t/h weigh feeder to kiln 7 under valid District permit number B005147.
