### **Description:**

BAGHOUSE - DCL 29 consisting of:a Mikro Pulsaire Model 400S-8-20-TR "C" baghouse equipped with 400 polyester bags totaling 3980 square feet of filter area and a fan generating 18,840 acfm through the bags (for an air to cloth ratio of 4.7:1). This baghouse serves the Drier Sizer System. This unit has the following pickup points: CLF02, ELV29 (head and tail), ELV30 (head and tail), ELV31 (head and tail), SMW01, SMW03, SMW04, SCH10, and SCH11.

- (b) Initiate a corrective action, within 24 hours; and,
- (c) Report/Document the excursion in the log book, required under condition 3, as a deviation (Title V Monitoring), breakdown (Rule 430), as applicable.

- (c) Report/Document the excursion in the log book, required under condition 3, as a deviation (Title V Monitoring), breakdown (Rule 430), as applicable.

The test is successful if no visible emissions are observed. If any visible emissions are observed, the owner/operator must initiate corrective action within 24 hours to return the baghouse to normal operation. The owner/operator must record each Method 22 test, including the date and any corrective actions taken, in the log required under condition 3.
