Description:

BAGHOUSE consisting of: A C & W Pulse Jet Model KR-1300, equipped with a 20 hp blower motor, 1256 sq ft of filtration area, Air to Cloth ratio of 6.37. Operates with a normal static pressure drop of 8 in WC at 8000 CFM. Device collects particles from the portable batch plant under District Permit B008529 Weigh Hopper discharge, and Truck Loadout shroud.

CONDITIONS:

1. The owner/operator (o/o) shall operate/maintain this equipment in strict accord with recommendations of the manufacturer and/or sound engineering practices.
2. The operating instructions shall be immediately available for use by the operator and provided to District personnel upon request.
3. This baghouse shall be operated concurrently with the Concrete Batch Plant process under valid District permit B008529.
4. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specifications which ensures compliance with District Rules. This program shall include, but not be limited to, monthly opacity readings, pressure differential measurements, and regular maintenance inspections. The results of the observations and inspections shall be logged with the log kept on site for a minimum of two (2) years. This log shall be provided to District personnel upon request.
