Description:

BAGHOUSE #5 (LOADOUT FILTER RECEIVER) consisting of: Baghouse; Manufactured by MIX; Model: MSELH6B35P1A18M28SG; Contains 35 filters, each measuring 120 mm in diameter X 2470 mm in Length. Total Filter Area = 35 square meters; Exhaust fan powered by 4 Kw motor, with a flow rate of 4 N cubic meters per hour; Air to Cloth ratio is 4.3. Baghouse vents internally within the Truck and Rail Receiving building. Equipment Elevation is 135 feet; Note: plant floor level = 100'

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer, supplier, and or sound engineering principles, which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. This air pollution control device shall operate concurrently with the INGREDIENT HANDLING SYSTEM permitted as B008779.

4. The owner operator shall conduct a minimum program of inspection and maintenance on this equipment, and maintain current and on-site for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request:
- a. Quarterly filter support system inspection date and results;
 - b. Date of filter replacements; and,
 - c. Date and nature of any system repairs.

5. This air pollution control device shall not discharge an exhaust stream that exhibits greater than twenty (20) percent opacity.

[District Rule 401]

6. This air pollution control device shall discharge no more than 0.017 pounds per hour of PM10 at a maximum concentration of 0.0006 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District.

7. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
