AIR POLLUTION CONTROL SYSTEM #14 (VACUUM EXHAUST OF HAMMERMILL #3) consisting of:A CPE Filters Model 25-PC-72-III dust collector with Solberg Model CSL-484P(2)-1200F paper element safety filter, with spun bond polyester pleated cartridge filters operating at 4630 cfm of flow.

CONDITIONS:

- 1. The owner/operator (o/o) shall maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.
- 2. This dust collector shall operate concurrently with Hammermill #3 (B008779).
- 3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and onsite for five (5) years a log of the following information, which shall be provided to District personnel upon request:
- a. Weekly dust collector stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- b. Quarterly cartridge and cartridge suspension system inspection date and results;
- c. Date of cartridge replacements; and,
- d. Date and nature of any system repairs.
- 4. This dust collector shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty percent opacity.

5. This dust collector shall discharge no more than 0.20 pounds per hour of PM10 at a maximum concentration of 0.005 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission
