#### **Description:**

ODOR CONTROL SYSTEM, LIQUID FLAVORING TANKS consisting of:two Calgon Corporation VENTSORB 55 gallon canister with 180 pounds of activated carbon each, in series, serving the headspace vents of liquid flavoring storage tanks 1, 2, 3, 4 and 5 through a common manifold. Device is not equipped with an integral manometer. Equipment Elevation is 100 feet; Note: plant floor level = 100'

#### CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]
- 2. The head space of liquid flavoring storage tanks 1, 2, 3, 4 and 5 shall be vented solely through this equipment through a common manifold.

3. This equipment shall not discharge an air stream with detectable odor, verified by weekly odor observations after the second VENTSORB unit.

- b. Date of VENTSORB canister change-out; and,
- c. Date and summary of any corrective maintenance.

5.The o/o shall maintain an on-site supply of VENTSORB canisters sufficient to maintain compliance with these conditions. [District Rules 204 & 1303]

6.Condensate from the liquid storage tank head space ducting systems shall be stored in a closed airtight container. [District Rules 204 & 1303]

7. This equipment shall be installed and controlling the head space exhaust of liquid flavoring storage tanks 1, 2, 3, 4 and 5 not later than August 31, 2006.
