BAGHOUSE #18 (DRY FLAVORING SYSTEM #3) consisting of:A CPE Filters Model 58-CT-9-III baghouse, with 9 6" D by 58" L 16 ounce polyester felt bags totaling 68 square feet of filter area, equipped with a 0.75 hp fan generating 100 cfm of flow driven by a pneumatic transfer system. This system is used only during intermittent transfer of dry flavoring to process line #3, and exhausts to atmosphere through a three inch diameter duct in the side of the finished product tower. Normal differential pressure across the integral baghouse cartridges is 2 to 5.5 inches water column as measured by integral manometer.
