Bin Vent System #44 (Bin 71), BULK INGREDIENT TOWER STORAGE consisting of: dust collector; Manufactured by KICE; Model: VC Filter; Contains 3 filters, each measuring 4.875 inch X 36.25 inch; Material: Spunbond Polyester. Total Filter Area = 31.5 square feet; Exhaust fan powered by 1 hp motor, with a flow rate of 125 cfm; Air to Cloth ratio is NA. This bin vent filter vents inside the Bulk Ingredient Tower.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer, supplier, and or sound engineering principles, which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. This air pollution control device shall operate concurrently with bin 71 in the Bulk Ingredients Tower permitted as B009827.

3. The owner operator shall maintain on-site a minimum inventory of replacement filters, if applicable, for this Bin Vent that assures compliance with these conditions and District Rules and Regulations.

4. The owner operator shall conduct a minimum program of inspection and maintenance on this equipment, and maintain current and on-site for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request:
- a. Quarterly Bin Vent stack observation date and result, using EPA Method 22, and EPA method 9 if Method 22 detects visible emissions, or In lieu of Method 9, owner operator may cease operations until deficiencies contributing to opacity are corrected.
 - b. Quarterly filter support system inspection date and results;
 - c. Date of filter replacements; and,
 - d. Date and nature of any system repairs.

5. This air pollution control device shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty (20) percent opacity.

[District Rule 401]

6. This air pollution control device shall discharge no more than 0.0063 pounds per hour of PM10 at a maximum concentration of 0.006 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District.

7. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
