a. Weekly visible emission readings, conducted according to EPA method 22 (if necessary EPA method 9), of the truck load out area and of the control unit exhaust area. These readings shall be taken during batching operations.  
b. Inspection/repairs

4. The maintenance log for this equipment shall be maintained with this equipment for two years and be made available to the District upon request.
