CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

- 2. This equipment shall operate concurrently with the Post Coat Vertical Cooler portion of Process Line #3 (B009720). [District Rule 1302]

The owner operator shall conduct a minimum program of inspection and maintenance on this equipment, and maintain current and onsite for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request: a. Monthly stack observation date and result, using EPA Method 22 (and EPA method 9 if Method 22 detects visible emissions. In lieu of Method 9, owner operator may cease operations until deficiencies contributing to opacity are corrected.);
- b. Cyclone system inspection date and results per manufacturer's recommendation, and,
- c. Date and nature of any system repairs.
