ELECTROSTATIC PRECIPITATOR consisting of: Trion Air Boss T1300, measuring 45" L x 25" W x 21" H, equipped with belt driven blower preset to 1300 CFM, ionizer/collector cell(s), pre-filters and after-filters and having a minimum control efficiency of 95%. This unit vents 3000 gallon capacity extender oil tank associated with B011616.
