Description:

HEPA VAC consisting of: Pullman-Holt Wet/Dry Asbestos Vacuum Cleaner with integral HEPA Filter System, Model 102ASB-12P, Serial No. 28702, with a maximum exhaust flow of 110 CFM, and having a rated capacity of 5 U.S. Gallons.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.
2. After each abatement use, this equipment must be emptied and cleaned within a negative air enclosure, and filters and waste collected with this equipment must be disposed as friable asbestos waste. [District Rule 1320 - New Source Review For Toxic Air Contaminants and 40 CFR 61, Subpart M - NESHAP for Asbestos]
3. This HEPA Vac machine shall be tested and checked for leakage and rupture after each HEPA filter change and prior to commencement of any abatement project.
4. The HEPA filters used in this equipment shall be certified by the manufacturer to have a minimum control efficiency of 99.97% on 0.3 micron particles. Owner/operator shall provide documentation of the filters certification to District personnel upon request.
5. The operator shall keep adequate records for this HEPA Vac machine to verify: a. The number of working hours per day involving asbestos removal; and, b. The date and time of each HEPA filter replacement; and, c. The date and time of each machine

8.The o/o shall notify the Compliance section at least five working days before commencing operation at any District location.
